Introduction:

At the start of the meeting, each attendee **introduced themselves**.

Reading of the minutes:

The **November 2015 meeting minutes** were read and approved.

Treasurers report:

The treasurer, McKosky, reported a balance of \$735.14. This total did not include the monies collected for dues during this meeting. The **treasurer's report** was approved.

President's Update:
